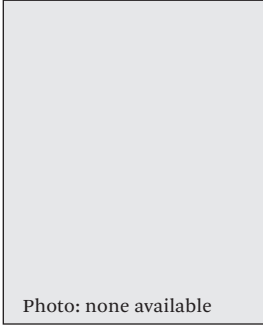
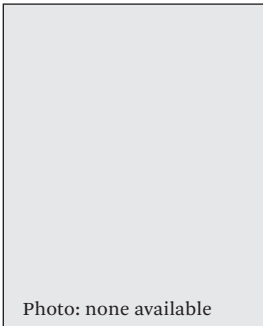


## Contributors

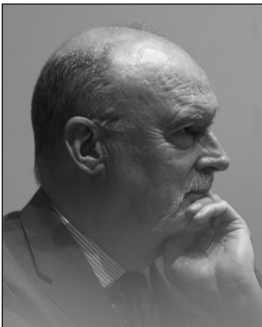
